2005 ANNUAL REPORT

Program Highlights

Guild Incorporated provides a full array of strengths-based, psychiatric rehabilitation services essential to support recovery and successful community living for people who have complex and long-term psychiatric illnesses.

Schizophrenia, bipolar disorder, and schizoaffective disorder were the most prevalent illnesses in 2005. Over half of the 1,142 individuals served had co-occurring disorders related to substance use and nearly two-thirds had at least one co-occurring physical health condition such as seizure disorder or diabetes. Two hundred ninety-three were served by more than one service or program within Guild.

It is known that nearly half of the people in our communities who are homeless have a mental illness or mental health problem. Guild is one of three providers serving adults in the MN Supportive Housing and Managed Care Pilot Project, designed to demonstrate success ending long-term homelessness. At the time of enrollment, in Guild's Delancey Street program in February of 2003, participants had been homeless an average of nine years. All had major mental illnesses; all had a diagnosed chemical dependency or substance use problem, and most had experienced violence in their lives. Delancey Street reaches out with a housing first approach and at the end of 2005, fourteen of thirty-four (41%) had been housed continuously for two or more years.

Individuals in psychiatric crisis can be stabilized in the community without becoming homeless and often without hospitalization. Seventy-eight of ninety-one (86%) individuals, who entered Guild's short-term crisis residential services from their own home in 2005, stabilized their situation without hospitalization for psychiatric care. Services help contain the cost of health care and can prevent homelessness.

In 2005, Guild Incorporated became one of sixteen initial providers in Minnesota, approved by the State, to provide Assertive Community Treatment (ACT) services. ACT is a nationally recognized and effective model of service designed to help people who have the most difficult symptoms of mental illness and who have had many hospitalizations.

Guild Incorporated employs 101 individuals and regularly hosts college interns through affiliations with a number of colleges including Augsburg, Bethel, St. Catherine's, University of Wisconsin at River Falls, and the University of Minnesota. In addition, seventy-three community-citizen volunteers serve in a variety of ways including helping to meet transportation needs and befriending those who are especially isolated.

These are only brief highlights from the year. Get to know Guild Incorporated—join us in helping others to find a home...their health... and, hope for their future.

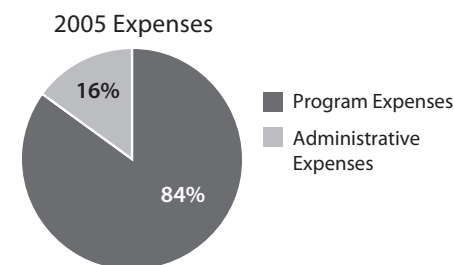
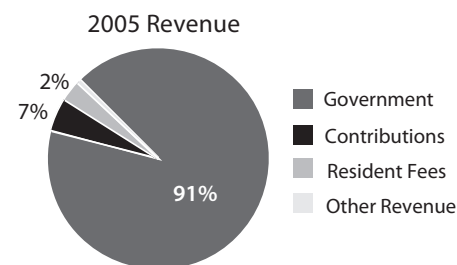
